1. PUPPY INFORMATION

2. PURCHASE PRICE

Total Purchase Price: \$4,500

Deposit (non-refundable*): \$500 **deposit will be refunded if a puppy is no longer available*

Balance Due at Pickup: \$4,000

3. REGISTRATION

This puppy is sold with **Limited Registration** through the American Kennel Club.

- Puppy **may not be bred** unless the Breeder approves in writing.
- Full registration **may be granted only if:**
 - The dog matures to breed standard quality, and
 - The Buyer participates in AKC conformation showing, and
 - Both parties agree to upgrade registration in writing.

4. CO-OWNERSHIP

This puppy is sold under **co-ownership** between Breeder and Buyer.

- AKC registration will reflect both parties as owners.
- Breeder retains rights to:
 - Approve any breeding
 - Require completion of all recommended health testing prior to breeding
- Buyer agrees not to breed, lease, or transfer ownership without written consent of Breeder.

Resolution of Co-Ownership:

Co-ownership shall be **automatically dissolved**, and full ownership transferred to Buyer, upon completion of BOTH of the following:

1. Dog obtains a CHIC number through the Orthopedic Foundation for Animals, AND
 2. Dog earns an AKC Championship title through the American Kennel Club conformation events
- Upon satisfaction of these conditions, Breeder agrees to:
 - Sign all necessary documents to transfer full ownership
 - Approve conversion to **Full AKC Registration**

Important: Dissolution of co-ownership **does not terminate or affect Breeder's stud rights** outlined in this agreement.

5. STUD RIGHTS (MALE INTACT DOGS ONLY)

Breeder retains **lifetime stud rights** to the dog under the following terms:

- Breeder is entitled to **up to three (3) stud services** at no cost
- These rights **remain in effect even after co-ownership is dissolved**

Buyer agrees to:

- Maintain the dog in good health and breeding condition
- Make the dog reasonably available for scheduled breeding
- Not permit outside stud use without Breeder approval

Additional terms:

- All breedings must meet health testing standards consistent with Orthopedic Foundation for Animals recommendations
- Collection, artificial insemination, and shipping costs (if applicable) are the responsibility of Breeder
- Stud services will be scheduled with reasonable notice and cooperation between parties

6. HEALTH GUARANTEE (1 YEAR)

Breeder guarantees that the puppy is free from **life-threatening congenital/genetic defects** for a period of **one (1) year** from date of birth.

If a licensed veterinarian diagnoses a qualifying condition:

Buyer must:

- Notify Breeder within 5 days
- Provide veterinary documentation

Breeder agrees to ONE of the following remedies:

1. **Replacement Puppy** (from next available litter), OR
2. **Shared Veterinary Expenses**, up to 50% of purchase price

Conditions:

- This guarantee does NOT cover:
 - Allergies, cherry eye, entropion, or minor correctable conditions
 - Injuries, infections, parasites, or environmental issues
- Buyer must maintain routine veterinary care

7. INITIAL HEALTH

- Puppy will be examined by a licensed veterinarian prior to placement
- Buyer has **72 hours** to have puppy examined by their veterinarian
- If serious health issue is found, Buyer may return puppy for full refund

8. FIRST RIGHT OF REFUSAL

If Buyer is unable to keep the dog at any time:

- Dog **must be returned to Breeder** or
- Breeder must approve new home

Under no circumstances may the dog be surrendered to a shelter or rescue.

9. CARE REQUIREMENTS

Buyer agrees to:

- Provide proper nutrition, veterinary care, and housing

- Not allow the dog to be neglected, abused, or used for unlawful purposes
 - Maintain dog as a companion animal

10. SPAY/NEUTER (PET HOMES)

- Dogs placed in pet homes **must be neutered by eighteen (18) months of age** unless otherwise agreed in writing
 - Proof of neuter must be provided to Breeder

11. NON-TRANSFERABILITY

This agreement applies only to the original Buyer and is non-transferable.

12. NO WARRANTIES

No guarantees are made regarding:

- Adult size, temperament, or show quality

13. GOVERNING LAW

This contract shall be governed by the laws of the State of Washington.

14. ENTIRE AGREEMENT

This document constitutes the entire agreement between parties.
